### President's Welcome

This year's webinar format to our AGM is a first for CMGA. While there's no substitute for face to face networking, in a year when we are transitioning to a new GM and planning a fall strategic planning session, a webinar format allows participation from the most members with a responsible element of cost control. It is my hope that this better accessibility to our AGM allows members from across the country to participate in discussion and stimulates member engagement in a way that will help fill current vacancies in the CMGA Board.

I am thrilled to introduce Catherine Michaud as our General Manager for the first time at this AGM. I am sure she is a familiar face to many of our membership and Catherine is bringing her same level of enthusiasm and professionalism to her new role as GM. I am grateful to Jen Haley and the entire Livestock Alliance team for all their efforts and top-service commitments in managing the CMGA through the previous two years.

GHIP summary reports are included in this package and while participation continues to be lower than hoped, it is fascinating to me to see the trend and speed of improvement to production traits. Generational turnover in goats is relatively short compared to some other farm species. These progressive breeders are showing us consistent and quick improvements to what they are measuring. One conclusion I draw from this is that as these breeders improve their herds so quickly, those breeders who are not measuring will fall behind very quickly. To me this is a great thing as it will force meat goat genetics across the board to improve as I assume unmeasured goats will become less valued, less marketable and largely irrelevant in breeding circles. So once again my message is to get on board with performance testing!

Type evaluation did not run in 2017 with a Board level discussion that annual participation and cost efficiencies may be both improved if the program is offered every other year. At the time of writing this the 2018 program is being offered to breeders and uptake in 2018 will give an indication to the Board whether every other year is an effective way to manage Type Evaluation.

The CMGA Show program continues to recognize phenotypic excellence in our herd book, as well as being an excellent family -building and networking social event and marketing tool. Congratulations to all exhibitors at every show and to the breeders of this year's Canadian Champions.

CMGA's balance sheet remains relatively healthy, however we have been budgeting deficits for the past few years and the 2018 budget deficit is uncomfortably creeping upwards. I have joked to the Board that we are starting to sound like a federal government who have promised "3 small deficits" only to see them creep up with no end in sight! The 2018 deficit is largely attributed to office transition expenses and a planned investment in a drastic website upgrade. The deficit is more palatable without these one-time expenses, however maintaining the office and current services with the existing income does continue to be tight. I suspect budgeting and prioritization will be a major component of this fall's strategic planning of the new Board.

I enjoyed a great article published in Canadian Cattlemen's magazine a few months ago by Brenda Schoepp which she called #moveover. She discussed the common difficulties participating on Boards and keeping an engaged and productive board effective, as well as the succession difficulties in filling board vacancies. The CMGA Board faces these same issues and with our AGM this year we have several unfilled board positions. In her article, Brenda addresses the issues that "no one will step up, " "they have no interest" and it's " hard to get folks to serve" by suggesting its takes a vacant space and the long term Board members to #moveover. I am ready to spend more time focused on my own farm and some of my other passions, so I am ready to #moveover. My ask of the CMGA membership is that they consider volunteering for the board, letting their name stand and that they #takeover.

### About the Canadian Meat Goat Association

In 1992, an enterprising group of Canadian entrepreneurs was instrumental in the importation of Boer goat embryos into Canada from New Zealand and France, and later directly from South Africa. On November 27, 1993, the Canadian Boer Goat Association was formed through an ad hoc process involving 7 charter members. On October 10, 1995, this Association was officially incorporated by Agriculture Canada under the Animal Pedigree Act, with official by-law approval coming on January 3, 1996. This approval provided sole authority as the only association approved to register Boer and Boer cross goats in Canada. The newly incorporated association, which had begun its registration process under the Canadian Livestock Records Corporation, moved to Canadian Beef Improvement Inc., and eventually began self-registry out of the Association office in Glenwood, AB, Canada.

From the very incorporation of the Association, the requirement was put in place for mandatory DNA sampling on every purebred registration. The purpose of this was to build a data bank of DNA from which a program of random parentage verification testing could be based. Presently, random testing is done on 1% of all purebred registrations submitted. The Canadian Boer Goat Association is the only Boer goat association in the world to have such a program, which is designed to maintain the integrity of Canadian Boer goat pedigrees.

The first CBGA-sponsored Boer Goat Sale was held in November of 1998 in connection with the Boer Goat Show at the Canadian Western Agribition in Regina, SK. Sanctioned shows with Canadian Boer Goat approved judges were started in 1999 with the first in July 1999 at Yorkton, SK. The Association has a judges training program to develop Canadian judges across the country.

In 2001, the Association office was relocated to eastern Ontario, and bilingual services became available to Francophone

producers. Since then, the Association has been working hard to offer all of its written materials, including the quarterly Canadian Meat Goat Journal and the web site, in both official languages.

In 2004, the membership of the CBGA voted to change its name to the Canadian Meat Goat Association and to expand its mandate to the broader meat goat industry in Canada. Since then, the Association has been developing educational and marketing tools for both commercial meat goat and purebred seed stock producers.

Other CMGA activities have included: a youth program, a buck test station, development of a type evaluation (classification) program, and representation at agricultural events across the country. The Association's Annual General Meeting is held early in the calendar year.

In 2009, the Association office was relocated to Saskatchewan, and the Canadian Livestock Records Corporation in Ottawa was contracted to process registrations and memberships.

In February 2016, CMGA joined the Livestock Alliance and the office was relocated to Guelph, Ontario. Veal Farmers of Ontario, Ontario Goat and the Canadian Goat Society were the other partners in the Alliance.

At the end of 2017, the CMGA and the Alliance decided to separate by mutual agreement. The office was relocated to Quebec.

The Association owes a tremendous debt of gratitude to the early pioneers of the Boer goat industry in Canada. Untold hours of volunteer labor and expense were donated to establish an organization and structure upon which to build the future industry. To this day, the Association depends on the commitment of its volunteer Board and committee members, who keep its many programs running.

### A. Treasurer's Report

You will find as a separated document that was sent to you with this Annual Report the reviewed 2017 financial statements for review by membership.

#### Notes regarding 2017 costs

#### Income

- We had more income from the Hoodie Campaign than we expected
- We budgeted nothing as revenue for advertising in the Journal because the production of the Journal was going to be done inhouse and we didn't know what to expect. Finally, we had a great surprise. Thanks to all Journal advertisers!
- The Type Evaluation Program didn't run, so we had no revenue from it as well as no expenses.
- The number of members declined in 2017, so we had less revenue from membership than what was expected, but the registrations, transfers and other related transactions brought higher revenue than expected.
- We had about \$3,300.00 less revenue than what was expected.

#### Expenses

- We had less Board expenses than expected because Board members travel was entered into AGM expenses and those were lower than budgeted. We also had less teleconference costs than expected.
- Ribbons costs were higher than expected because show participation was higher as we will see in the show report.
- As previously mentioned, Type Evaluation Program didn't run, so we had no related expenses.
- General Manager's salary was slightly higher than expected.
- As mentioned above, we didn't budget any sums for the Journal because the production of the Journal was going to be done inhouse and we didn't know what to expect. We finally had a little more than \$1,700 in expenses for that item.
- Membership expenses were higher than expected mainly due to our increased activities in registration and transfer and the fact that CLRC now charges us the credit card fees.
- Total expenses were about \$5,000 less than budgeted.

Overall, we observe a deficit as it was expected, but for about \$1,700 less.

#### 2018 Budget

The 2018 budget was discussed by the Board of Directors at their meeting on April 24th, 2018, was approved on May 14th and is presented on pages 12 and 13.

Factors influencing decisions surrounding the 2018 budget include:

- Recruiting more members and promoting Boer and Kiko goats' registration.
- Moving CMGA office to Quebec.
- Prioritizing members communications with the Canadian Meat Goat Journal and the Website as well as on regular communication through emails to members and Facebook page.
- Gain efficiency by automation of banking transaction and accounting to free GM's time in order to reduce the number of hours of work necessary for CMGA business. This will reduce expenses related to GM salary and prioritize GM time for members communications.
- Organize Board members face-to-face meeting in Fall for Strategic Planning. The last Strategic Plan expired in 2017.

Some expenses expected for 2018 are one-time expenses such as Website (\$6,500), face-to-face meeting (\$5,000) and additional GM salary to ensure office transfer (\$5,760). When removing those items, we're left with a surplus of \$4,547.40.

As always, maintaining a balanced budget while continuing services to members remains a priority for the Board.

### **B.** Production

#### **Type Evaluation Program**

CMGA did not offer the Type Evaluation program to membership in 2017. The program has been offered to membership every year since 2008 (with the exception of 2015 due to organizational changes that were underway). To date, our Type Evaluators have now evaluated over 1500 animals across the country.

Type Evaluation utilizes a linear appraisal system to "score" an animal (and it's respective parts) against the "ideal" for the breed. Type Evaluation offers breeders an opportunity to have an objective evaluation performed on their animals by a trained CMGA classifier.

The CMGA Type Evaluation system was modeled along the lines of similar programs offered by other breeds of livestock (ie. Cattle, dairy goats, etc), keeping in mind the traits that are considered economically and conformationally desired in the Boer breed.

Both registered Purebred does and bucks, and registered percentage does are eligible for Type Evaluation. In order to be evaluated, does must have kidded at least once, and bucks must be at least 1 year old at the time of evaluation.

Animals are given an overall total score (out of 100), and are placed as follows:

Excellent - 90+

VG - 85-89

Good - 80-84

Those animals scoring Very Good (85) or higher have been published in the MGJ as well as being published on the CMGA website. As of 2014, the scores of animals being evaluated have also been available on the CLRC website.

For the 2016 year, evaluations took place in Saskatchewan, Ontario, and Quebec with 220 animals being evaluated.

#### **Goat Herd Improvement Program (GHIP)**

The Goat Herd Improvement Program (GHIP) is free of charge to members and was first offered in 2012.

The program is a collaboration with Dr. Ken Andries from Kentucky State University, whereby producers can submit data and receive standardized on farm performance data on their does, kids, and bucks.

The collaboration took place because of CMGA's desire to build on existing programs, and to provide extra value to membership regarding data for selection of breeding stock. Our show program and Type Evaluation program provide feedback to producers on animals regarding phenotype and conformation to breed standards, while GHIP adds to the equation by providing information on the productive/performance capabilities of that animal.

GHIP provides a tool that allows producers to have production records standardized and assists them in using performance data to select higher quality animals for replacements. This can result in herd improvement and increased performance without increasing production costs for producers. After submitting your data, comprehensive reports are sent back to the producer on average daily gains for the kid crop, efficiency ratios on the does, sire summary indexes, along with other valuable information.

Information submitted to the GHIP program is anonymous. CMGA does not receive back the individual results from herds that enrol in the program. Rather, at the end of each year, CMGA receives a summary of the data submitted from Dr Andries that helps us to begin to build a database to create benchmarks for important production traits such as number of kids born, birth weights, average weaning weights, etc.

It's interesting to observe the improvement of weaning weight (WNWT), average daily gain (ADG), 90 days weight (90D WT) and adjusted weight (ADJ WT) performances in the kid data summary.

In the doe data summary, we can also see that the litter size and then the number of kids weaned per doe (kids WN/doe) have increased respectively from 1.98 to 2.02 and from 1.62 to 1.88.

Of course, we need to stay prudent when interpreting those results because from year to year, farms are not all the same and with lower number of animals involved in the database, data are becoming less precise, but still it's encouraging to see that GHIP is helping producers to improve their performance results.

The number of shows was slightly higher in 2017 compared to 2016 (5 shows) and total number of animals in competition increased from 214 in 2016 to 312 in 2017.

Showing is a great way for individual breeders to showcase their individual herds and an opportunity to promote the meat goat industry. CMGA would like to thank everyone who took the time and effort to get their animals into the show ring in 2017 and we hope to see you back again in 2018!

Updated show rules

Two updates have been made to the show rules and will be applied to the 2018 show season:

- 1. Section C, paragraph 2 AND Section H, paragraphs 8 and 9: The Report of Awards (ROA) completed and signed by show secretary, show president, judge and exhibitors must now be returned within 21 days of the conclusion of the show (instead of 60 days). This will allow for a faster compilation of show results and publication in the different CMGA media. If the ROA is completed and signed how it's supped to be, i.e. at the show venue, shortening the delay for sending it back to the CMGA office should not cause problem to show organizations.
- 2. Section C, paragraph 9: When the judge is examining teats on a buck, for the safety of the judge, it is the exhibitor's responsibility to control the buck's movements by turning the buck's head, etc..
  - A. It is at the discretion of the judge to lift the buck's leg themselves or to request the exhibitor to lift the buck's leg.
  - B. If the exhibitor is unable to control the buck and/or lift the leg properly, the exhibitor must find an extra handler(s). The onus is on the exhibitor to constrain the buck and to position the leg, so the teats can be seen by the judge.
  - C. If the judge is unable to examine the teats of a buck, then the buck teats cannot be properly assessed, and the buck shall be placed last in his class and in no event shall that buck be included in the champion selection lineup.

This new rule will insure that all the right conditions are in place in the show ring for the judges to proper examine the teats of the bucks. To obtain a copy of the updated show rules, visit our website at https://canadianmeatgoat.com/rules.

necessary forms (e.g. show sanctioning forms, health check forms, etc.). A handy show committee checklist and a document outlining how to go about organizing a show can also be found on the website.

All forms and instructions are sent along with the ribbons to the show organizations who sent their application and payment for CMGA sanctioned shows.

#### Sanctioning Revoked for St. Hyacinthe Show

Sanctioning was revoked because for the second year in a row, the paperwork was not done properly. For example: date stated on the Report of Awards (ROA) was August 10th, so it was filled out after the show, the tattoo numbers were not filled out on the ROA and the Judges and Exhibitors signatures were not complete on the ROA form. It's important that the tattoos must be written on the ROA by the show secretary as they are read from the judge in the show ring. Show secretary, show President, Judges and winning exhibitors must make sure that the information written on the ROA is correct and that they sign the ROA and before leaving the show venue. It is in the show rules and will be enforced. All show actors (participating producers, judges, show secretary, show president) have responsibilities towards mandatory paperwork requested by the CMGA. This goes with the credibility and professionalism of the CMGA sanctioned shows which results are published in the CMGA media and are used for calculating the CMGA Show Champions.

### E. General Manager

But at the end of the year, the Livestock Alliance and the CMGA have agreed to not renew their contract. The office continued to be challenged with several important activities and priorities of the organization, but not having the staff resources required to fulfill them and the CMGA budget could only go so far and it was not fair to ask the other Livestock Alliance partners to pitch in. In January 2018, the CMGA board hired me, Catherine Michaud, a former CMGA director for the last 13 years, to take on CMGA business and activities organisation.

In 2017, the Alliance staff continued to organize and produce two issues of the Meat Goat Journal (MGJ) and continued to send the electronic newsletter to members via email. For 2018, the MGJ distribution will continue with 2 issues and electronic newsletters and the partnership will continue with the Goatkeeper to promote the CMGA activities.



#### GM.



#### Registrations

Boer registration numbers increased over 2017, but didn't get back to the 2013 and 2014 figures, while Kiko registrations numbers declined. Registering your meat goats helps with developing your breeding programs, especially for those who take part in Type Evaluation. You can't manage what you don't measure. Remember registering your goats is a great way to maintain records and help build on your herd genetics.

### F. CMGA Constitution

In accordance with Article XII of the CMGA by-laws,

"This constitution may be amended by a resolution at any Annual or Special Meeting of the Association by the affirmative vote of two-thirds of the members present voting in person or by proxy as stipulated in ARTICLE IV (1) (b). Notice of all proposed amendments shall be given to the President and/or General Manager in writing ninety (90) days in advance of a General Meeting. All proposed amendments will then be subject to a by-law review process by the Constitution Committee which shall include, but shall not be limited to, consultations with Agriculture Canada. The Constitution Committee shall provide the Board with a report containing the results of its review and a copy of such report shall be sent to each of the said proposing members. Once reviewed and approved by the Board, in accordance with previously-established policy and procedures, amendments shall be included in the notice calling the General Meeting, otherwise the meeting shall have no power to deal with same. "

No amendments to the CMGA by-laws were received for the 2017 AGM.
